Program Enrollment/Graduation Numbers

Goal Description:

Program Enrollment and Retention

KPI Description:

The number of students in each major and the number of students graduating in each major will be measured and compared over time. This is the first tracking year for this KPI. We are identifying a baseline measure for this year and will compare our findings to the numbers for the next academic year to begin identifying trends.

Results Description:

For Fall 2016 we had a total of 28 graduates; 9 Dietetic Master graduates; 4 Family and Consumer Sciences; 7 Fashion Merchandising; 7 Food Science and Nutrition; and one Interior Design. For Spring 2017 we had a total of 31 graduates; 1 Dietetic Master graduate; 8 Family and Consumer Sciences; 10 Fashion Merchandising; 3 Food Science and Nutrition; one Food Service Management and 8 Interior Design. For Summer 2017 we had a total of 7 graduates; one Family and Consumer Sciences Master level; 1 Fashion Merchandising; 1 Interior Design and 3 Family and Consumer Sciences.

Our enrollment data will also serve as a baseline, and we will track increases or declines on a yearly basis. As of 5/8/17, we show 10 Diete c Master graduates; 41 Family and Consumer Sciences, of which 17 are Secondary Education minors; 46 Fashion Merchandising; 70 Food Science and Nutri on; 17 Food Service Management; and 47 Interior Design.

Results Description:

Forty four interns completed the final evaluation for this reporting period. Students were asked to respond to the statement "Facilities prepared the student for internship." Students were offered five choices for responses; excellent, very good, good, fair, or poor. These choices correlated with numerical values 1-5. Data analysis considered the students agreed the facilities were satisfactory if they selected a rating of excellent, very good, or good.

Ninety-one percent of students rated the facility as satisfactory (40:44), with an overall mean score of 3.8.

Results Description:

Forty four students completed the final evaluation. One item on the evaluation asks for students to indicate their level of satisfaction with faculty instruction. Four response choices are offered: very satisfactory, satisfactory, unsatisfactory, or very unsatisfactory. These choices correlated with numerical values of 1-4. Three students scored this item with a 5, so those responses have been disallowed. Forty of the remaining respondents responded very satisfactory or satisfactory. One student responded with a 2, unsatisfactory. IDEA scores provide additional insight into the quality of instruction and are used as an additional assessment measure in Family and Consumer Sciences.

For the Fall 2016 reporting cycle, the FCS Department rated above the national results by two points in the category of Progress on Relevant Objectives (51:49), rated at the national level in the category of Excellent Teacher (50:50), rated one point ahead of the national average in the category of Excellent Course, and two points ahead of the national average in the category of Summary Evaluation (52:50).

For the Spring 2017 reporting cycle, the FCS Department rated above the national results by one point in the category of Progress on Relevant Objectives (50:49), rated below the national level in the category of Excellent Teacher (47:50), rated one point below the national average in the category of Excellent Course, and at the national average in the category of Summary Evaluation (50:50).

Closing Summary:

The final evaluation questionnaire will be updated to provide more than one indicator of facility quality. We can include ques ons related to the specific programs, and especially those programs with lab facili es.

We will also update the instrument to provide more in depth rang of faculty effec veness. We will discuss adding addi on al measures from the IDEA outcome measure to accurately reflect the overall effec veness of instruction in FACS.

Faculty annual reports will reflect a longer time period for the new faculty who have joined us. We will continue to support faculty presentations and publications through resource allocation. Faculty who are struggling with teaching effectiveness will be encouraged to take part in teaching conferences.
