Expected completion date is July 1, with first use at New Student Orientation on July 20.

Results Description:

According to internal tracking records, totals for student participation numbers in residence hall programming for the 2016-17 academic year were 9055 attendees at 216 programs, as compared to 11,625 attendees at 238 programs during the previous academic year (2015-16). Student participation decreased by 22%. This is possibly due to a lesser number of programs (22) offered.

Update to Previous Cycle's Plan for Continuous Improvement

Previous Cycle's Plan For Continuous Improvement (Do Not Modify):

Our attendance rates at residence hall programs and the 84.4% positive rating of residence hall programs on our end-of-year survey indicate that we are doing a good job and that our Programming model is effective. We plan to continue using our same model, but will strive to continue to improve both attendance and satisfaction rates.

The popularity of Belvin-Buchanan Hall and the Fine Arts and Mass Communications Creativity Community facilities is our motivation to begin planning Phase Two of the renovation of that space to include a wet/dry art studio. We can begin designing a plan for that space as soon as the bakery moves out, projected in summer 2017. The success of this area also serves as an inspiration to plan similar spaces for living-learning communities in other disciplines.

Update of Progress to the Previous Cycle's PCI:

Instead of continuing with our same programming model as planned, we changed the model to better reflect the University's 60x30TX plan. Our programming attendance rates decreased slightly this year as a result of this, as we actually offered fewer programs overall, but they were wellattended. We plan to continue using this model, but will strive to continue to improve both attendance and satisfaction rates.

The popularity of Belvin-Buchanan Hall and the Fine Arts and Mass Communications Creativity Community facilities is our motivation to begin planning Phase Two of the renovation of that space to include a wet/dry art studio. However, the retention/renewal rate for the last two years has only been around 19% rather than the expected 25-30% Phase Two planning is likely to be delayed due to availability of funding as well as desire to see a larger retention rate prior to sinking further monies into this project .

Plan for Continuous Improvement through 2018

Closing Summary:

Our new residence hall, Piney Woods was completed and opened on schedule. We did a partial opening for the last two Orientation sessions, beginning July 20, and then did a complete Opening for Fall Move-in. This allows our Facilities Maintenance staff to concentrate on some larger renovation and repair projects next year, including finishing some HVAC work in Elliott Hall in particular.

We are going to be monitoring our new Programming model this next year to make sure we are performing the way we want to with respect to Programming.

We are pushing back our plans to design Phase Two of the FAMC Creative Community until we are able to more comfortably fund it, as well as ensure that our renewal/retention numbers for this building increase from 19% the last two years to somewhere between 25-30%.
