Update to Previous Cycle's Plan for Continuous Improvement

Previous Cycle's Plan For Continuous Improvement (Do Not Modify):

For the 2016-2017 academic year, continued emphasis will be placed on strengthening the VS BA/BS program. There has been a lot of change administratively that has impacted the progress of the VS undergraduate program. The department has a new chair and as a result, the responsibilities of the undergraduate program director have shifted. In the upcoming year, the Chair and Undergraduate Program Director will clarify who is responsible for overseeing the program's development.

The program continues to struggle with appointing a faculty or instructor who is primarily responsible for the program's capstone course (CRIJ 4398). The necessity of this course will be discussed by the Chair and Undergraduate Program Director.

Update of Progress to the Previous Cycle's PCI:

During this assessment period, the Department Chair and the Undergraduate Program Director continued to engage in critical dialogue about the direction of the Victim Studies Program and the challenges specific to the Capstone course. As predicated, it was difficult to find faculty who were interested in teaching the course. Moving forward, they will continue to explore whether the Capstone is needed. After careful consideration of the VS program's administrative needs, a faculty member was appointed to oversee next year's assessment.

Plan for Continuous Improvement

Closing Summary:

As previously noted, a primary challenge with offering the Capstone course concerns instructor coverage. In the 2016-2017 academic year, CRIJ 4398 (Problem Analysis in Victim Studies) was taught by part-time instructors (a Doctoral Teaching Assistant and adjunct faculty.) For quality assurance purposes, a concerted effort was made to identify full-time faculty willing to teach the course. In the next academic year, it will be assigned to two tenured professors. A committee was recently convened to address Victim Studies program needs. In the next academic year, the committee chair will be responsible for all Victim Studies BA/BS program assessment. Such assessment is anticipated to include a more nuanced analysis of the grading rubric domains. The committee will consult with the Office for Academic Planning and Assessment to identify additional outcomes. Finally, the Department Chair and the Undergraduate Program Director will continue to engage in important dialogue about the direction of the Victim Studies program.
