

Appointments. The Provost and Vice President for Academic Affairs makes all appointments from nominations submitted by the academic deans and Director of the Newton Gresham Library. The committee consists of one Associate Dean from each academic college, who serves on the college-level curriculum committee; one faculty member, from each academic college, who serves on the respective departmental curriculum committee (if relevant) and college curriculum committee; one faculty member from the Newton Gresham Library; and ex-officio members to include one staff member for Academic Affairs and one staff member from the Registrar's Office. The Associate Deans, library representative, and ex-officio members serve indefinite terms; the remaining faculty members serve two-year terms with half of the appointments expiring each year. One faculty member is nominated each year by the University Faculty Senate to serve as chair-elect for the committee, serving the following year as Chair. The Chair serves a one-year term. The Chair must have previously on a college or university-level curriculum committee.
